#### Introduction (Chinese):

# Introduction (English):

This course is divided into two parts. The first part presents an overview of the General Provisions of China's Civil Law, including the concept, characteristics, and sources of the Chinese civil law, general principles of China's civil law. Then, the civil rights system, the legal status of natural person and legal person, civil legal acts, agency, and the limitation of action are introduced in this first part. The second part introduces the China's Real Rights Law. Basic principles of the China's Real Rights Law, including the dichotomy of movable property and immovable property, the creation, alteration, transfer and extinguishment of real rights, the registration of immovable properties, and the protection of real rights are introduced firstly. Then some important system in the Real Rights Law such as the ownership, co-ownership, neighboring relationships, usufruct, lien, and possession are presented.
